

TOP NEWS

- From 1st July to 30th September 2025, the M&E Cell conducted 351 site-monitoring visits across provincial departments. The largest shares were to Local Government (88 schemes) and Works & Services (55 Schemes), alongside visits in Health, Irrigation, Public Health Engineering and other sectors.
- By asset type, these visits covered 150 roads/bridges & paving works, 55 education facilities (schools/colleges/universities), and 39 water & sanitation schemes (water supply, sewerage, drainage), with additional checks of health facilities, heritage sites and multi-sector projects. All visit findings were verified on-ground and published in FilMS."
- Across the schemes monitored this period, the published schemes cost Rs 105,624.238 million i.e., ≈ Rs 105.624 billion.

MESSAGE OF DG (M&E CELL)




